Selected Adoptive Program Fees

The following is a breakdown of fees and payment expectations for the adoption process and post placement services.

DOMESTIC ADOPTION FEE

Application Fee \$ 350.00

Home Study Preparation \$ 2,100.00

This includes office interviews and home visits with all family members present
This also covers telephone, postage and basic photocopies fees associated with Home Study preparation

Education Fees \$ Varies

Periodically the Agency will offer Parent Training. Cost for this training will vary from \$20.00 to \$50.00 per person depending on where the training is held and whether the Agency has to pay rent to use the facility. This training or a similar type of training is required for adoptive parents and must be completed no later than 6 months after you have initiated your home study. This may impact on when a child can be placed with a family. In the event that families participate in web-based training, the actual cost of that training will be paid by the adoptive parents.

Adoption Client Internet Marketing Fee \$ 3,000.00

Interstate Processing Fee \$ 1,500.00 to \$2,000.00

This fee only applies if this is an Interstate Placement. It does not include ICPC Processing Fees for the cooperating state.

A. Exit Fee \$1,000.00 to 2,000.00

B. Entering Fee \$ 500.00 to \$1,000.00

Placement Fee \$ 12,000.00
As applicable
In addition, the adoptive family pays medical expenses, and living expenses, birth parent and Agency expenses, (i.e. mileage, mailings, copying, postage, etc.)

Post Placement Fees \$ 350.00
This fee applies when the adoption is Agency Assisted, an Interstate Placement, or for subsidy requirements. This fee is per each

post placement.

Mileage Charges

Mileage charges are billed at the standard IRS fee for any mileage.

Home Study Fee	\$	1,000.00 to 2,000.00

INTERNATIONAL ADOPTION FEES - NON-HAGUE

Application Fee	\$	500.00
Home Study Preparation Actual costs will depend on the specific foreign country.	\$	3,600.00 - 5,000.00
International Processing Fee For outgoing cases only	\$	5,000.00
Parenting Training for International Adoption	\$	Varies
International Post Placement Fee	\$	500.00

Should the adoption become a contested case and Agency employees are required to attend court, depositions, meetings with their attorney, or prepare additional reports as requested by the courts or attorneys, an hourly rate of \$125.00, plus expenses will be charged.

Additional services not listed above will be billed at \$125.00 per hour.

All fees must be paid prior to finalization in domestic cases.
